

Palm Beach State College Personalized Education Plan (PEP) Students DUAL ENROLLMENT/ EARLY ADMISSION ARTICULATION AGREEMENT



Eligible Personalized Education Plan (PEP) students in grades 6-12 must have earned four (4) high school credits, one of which must be a high school English Language course and one a high school mathematics course. The student must also demonstrate college ready scores on an accepted <u>college placement test</u>. A student is limited to earning a **maximum of 60 credit hours** through dual enrollment and/or early admission. - 1. **Dual Enrollment:** The student may dual enroll in up to eight (8) credit hours in the Fall, Spring and Summer terms regardless of the number of institutions attended.
- 2. Early Admission: Eligible students who have completed the 11th grade (or its equivalent) may complete their senior year at Palm Beach State College upon approval from their parent/guardian. Interested students must submit a written recommendation letter from their parent/guardian for the Early Admission program. Early Admission students must maintain full-time status, 12 credit hours per semester, Fall and Spring terms only. In addition, students must maintain a 2.0-term GPA in college-level work. If a student enrolls in the Early Admission program, the Fall and Spring will be the conclusion of the Dual Enrollment and Early Admission program at Palm Beach State College.
- 3. Career Certificate (CCP) Dual Enrollment/Early Admission: Students in grade 10-12 can enroll in an eligible CCP that leads to a <u>state approved certification</u>. All program requirements must be met, including placement testing/TABE exam.

PEP students taking dual enrollment courses must enroll in academic courses that count toward the completion of a high school program. The student must meet all entry requirements, including satisfactory test scores and prerequisites for any course. Furthermore, the student must make a grade of "C" or better in all dual enrollment courses to continue in the Dual Enrollment program.

Courses: Dual enrolled students may not enroll in physical education courses, college preparatory courses, courses less than three credit hours unless they are co-requisites of an approved course such as a science and the corresponding lab. The *High School Subject Equivalency List* is located online at www.fldoe.org/articuation/pad/DEList.pdf.

Appeals process: Appeals are submitted to the college-wide Appeals Committee. Considerations and exceptions are made on a case by case basis and by following the Florida Statutes and Rules. For an appeal to be considered, the student may submit a letter of appeal explaining extenuating circumstances and providing documentation to support the case. Documentation shall include a student's transcript, test scores (SAT, ACT, PERT, or TABE for PSAV programs), high school portfolio, if applicable, auditions, letters of recommendation, and evidence of dual enrollment counseling. The decisions of the Appeals Committee are final.

Students taking dual enrollment courses are subject to the rules and regulations of Palm Beach State College as stated in the Catalog and Student Handbook, including a mandatory **Information/Advising session or Dual**

- Enrollment Orientation. At an institution of higher education, students are exposed to a learning environment that promotes an open exchange of ideas. Course content is presented on an adult level where class discussions require a mature
- understanding of divergent viewpoints and the ability to think critically on controversial issues. Students of any age enrolled in a postsecondary institution have their rights under FERPA transferred to them. Records <u>MAY</u> be released only through express written permission by the student via the <u>FERPA</u>
- Waiver. PBSC will not provide any information to a parent without the student's consent of release. Dual enrollment students who receive withdrawals and/or a failing grade may have difficulty in meeting future admission requirements at colleges and universities including financial aid and scholarship
- opportunities. Dual enrollment students who receive a D or F in a course will not be allowed to enroll in future dual
- enrollment courses at Palm Beach State College. Resources and services are available for students with disabilities. The Center for Student Accessibility (CSA) assists students in obtaining reasonable accommodations. The student will submit copies of the documentation prior to the beginning of the term (at least three weeks prior to date of requested services) verifying the disability and facilitate contact with the Center for Student Accessibility (CSA) at PBSC:

 Dual Enrollment students who withdraw from a class will not be allowed to enroll the following semester.
 To re- enroll in the Dual Enrollment program (after one semester) students must appeal to the Dual
- Enrollment Office: https://www.palmbeachstate.edu/dualenroll/counselor-resources.aspx Instructional materials assigned and required for use within dual enrollment courses shall be made available by PBSC for PEP students at no charge to the student.
- PEP students who dual enroll are responsible for fees other than tuition, including, without limitation, consumables, kits, fines, transportation, etc.
- > Students must reside in Palm Beach County.
